 3 Beacon Mews South Road Weybridge Surrey KT13 9DZ: Planning Application <u>2022/3403</u> Appeal Reference APP/K3605/W/23/3324192

This application for a first-floor extension to create an additional flat was refused by Elmbridge on <u>several grounds</u> in February 2023, including lack of off-street parking provision. TRG and 20 residents objected. TRG's objection can be seen <u>here</u>.

An appeal has now been lodged with the Planning Inspectorate and will be determined by written representations.

TRG is preparing a response to the appeal.

This application for change of use of an existing commercial building to residential use and conversion to two one-bedroom dwellings was refused

by Elmbridge on <u>several grounds</u> including lack of provision of off-street parking.

3. Land North West of Campbell Cottage & 1 Beacon Mews South Road Weybridge Surrey KT13 9DZ Planning Application 2022/0461, Planning Inspectorate Appeal Reference: APP/K3605/W23/3315453

An appeal was lodged on 9<sup>th</sup> June 2023 for this outline application for a detached two-storey building to provide offices for class E(g)(i) with associated parking, bin and cycle stores.

Outline planning application had been granted in July 2022 but the applicant appealed against one of the conditions imposed by EBC (Condition 12).

The appeal has not yet been decided.
