3. Receiving the Committee's report

NJT presented the Committee's Report to a lively meeting attended by residents in which discussion focused on the agenda items as listed.

- Concern was expressed at the sanitary arrangements, smell and disturbance (particularly from delivery drivers) should the retrospective application for a kebab outlet in the Jolly Farmer garden be approved. In this eventuality residents would have to take the specific matter up with the outlet's owners and the appropriate EBC officials
- Thanks to a donation on the night, TRG's credit balance now stands at £60

5. Traffic and parking in the Triangle

NJT summarised the history of discussions between TRG and Surrey CC and talked through the three options that would be taken forward for

consultation with residents, the option that would not be pursued and the action points that had been left with SCC to respond on.

He outlined the proposed consultation process.

Several points were made by attendees:

- Could York Road south be included in a residents' parking permit for the proposed Princes Road & New Road scheme as overlapping driveways and restricted sightlines are common there too?
- Could the two principal roads be closed on a trial basis?
- Could a greater response rate to the survey be achieved through speaking to residents on a cold call basis?
- Could WhatsApp and other media be used to encourage the survey response?
- The proposals won't do much to address road speeds in Pine Grove
- Could a flashing speed sign be installed in Pine Grove?
- Could residents be empowered to use speed guns? (it was pointed out this had been tried but the effects didn't last)
- Enforcement of parking restrictions was poor following the transfer of responsibility from EBC to SCC and the activity's outsourcing to a third party.

NJT asked the meeting whether the views of those attending were in line with the views put forward by the Committee's Report. They were overwhelmingly accepted by those attending.
